We are also a leading employer and economic driver in the tri-state region of Nebraska, Iowa and South Dakota.

YEAR IN REVIEW

Ho-Chunk, Inc. revenues topped \$380 million in 2022 and we now employ more than 2,000 people and growing.

In our rural tribal reservation, we've shifted from fighting to thriving.

In 2022, we made big steps into an exciting new chapter for the company that will help the Tribe define its future in historic ways.

On the business side, federal contracting is a significant and growing financial driver of that mission as the company continues to diversify across a range of industries across the nation and abroad.

I look back and am humbled by the progress since we started serving federal customers in the early 2000s. Today we are an award-winning prime contractor and have become a notable success story of the SBA 8(a) Business Development Program for minority and disadvantaged businesses.

In Nebraska, we are defining the newly established gaming industry with innovative entertainment and racing facilities in the state's largest cities.

Our diversified portfolios of businesses in real estate, construction, homebuilding,

retail, manufacturing, and other industries also significantly contribute to our award-winning total approach.

As a result, we've measurably improved life in less than a generation. With the continued business growth today, we are poised to exponentially invest in the future of the Winnebago people, empowering the community's youth to reach beyond what was once thought possible.

Development for the Ho-Chunk Village.

This master-planned community on the reservation has added 54 singlefamily homes and 81 apartments and condos. An additional 40 acres are in development, bringing even more opportunities for our people. And, for the first time, generational wealth.

Nearby, Ho-Chunk Farms is advancing tribal economic, health and cultural priorities. The Ho-Chunk, Inc. division leases tribally-owned farmland, helps the Tribe repurchase lost reservation farmland, and partners in the community on gardening and cultural programs.

Our community development efforts also include an employee-donations program that has raised over \$335,000 for community organizations. Scholarship and youth development programs are helping the next generation realize opportunity in the workforce.

I've worked for this company and my Tribe nearly my entire adult life. I have never felt better about our future.

BUILDING OUR COMMUNITY

Across Winnebago, the construction of new homes, community buildings and roads are tangible symbols of hope and progress. The company's use of Federal Relief Funds and New Market Tax Credits are critical to successful rural development and food sovereignty.



HO-CHUNK FARMS

Ho-Chunk Farms was established in 2012 to increase the Winnebago Tribe's farmland lease values by creating competition on trust land and to separately begin buying back non-trust farmland within the reservation. Ho-Chunk Farms saw its first ever profitable year in 2021 and continues to grow and diversify into the future.

- 6,400 acres of farmland being farmed
- \$1.4 million farmland lease payout to the Winnebago Tribe in 2022
- 930 acres of land dedicated to organic farmina
- Invested \$1 million ARPA funding for farming equipment and grain storage
- Started an ag program at Little Priest Tribal College in 2022
- Broke ground on a regenerative poultry operation in 2022 in partnership with the Winnebago Tribe, with plans to include 2,000 egg laying hens.

Ho-Chunk Farms promotes food sovereignty across the Winnebago Tribe.

HO-CHUNK VILLAGE 2.0

Housing is a critical priority in Winnebago, Nebraska. The Winnebago Tribe and Ho-Chunk, Inc. are helping more Tribal members realize the dream of home ownership and create generational wealth through community-wide programs and developments. Recent federal funds from the CARES Act and Indian Health Service have accelerated infrastructure development on a 40-acre expansion to the master-planned community that will create approximately 200 more living units. The \$50 million Ho-Chunk Village 2.0 development includes 120 apartment units, 32 townhomes, 10

The Ho-Chunk Way Employee Donations Program builds on the mission of Ho-Chunk, Inc. to improve lives in the Winnebago community. Since the program began in 2017, over \$400,000 has been raised for Winnebago organizations, including employee donations, donations from the public and matching funds from Ho-Chunk, Inc.

elder homes and 35 single-family homes.

In addition to federal funds, Ho-Chunk, Inc. plans another \$4 million investment to pave sidewalks, install lighting and plant hundreds of trees.



HO-CHUNK WAY

In 2022, Winnebago Tribal Farm was the recipient of Ho-Chunk Way donations, which will be used to help expand farm operations, purchase food storage equipment and make facility updates. Sights are set on increasing egg and meat production, in addition to providing classes on cooking, canning, beekeeping, gardening and more. All these initiatives work together to advance food sovereignty.

Previous Ho-Chunk Way recipients include Whirling Thunder Wellness, Winnebago Youth Shelter, Ho-Chunk Renaissance, the Winnebago Boys & Girls Club and the Winnebago Senior Center.



WarHorse Casinos will also open in Omaha and South Sioux City. WarHorse broke ground at Horsemen's Park in Omaha in July 2022. WarHorse South Sioux in South Sioux City, Nebraska will be the third WarHorse property built.


